Impact of COVID-19 on MSME and the way forward

The development of the Micro, Small & Medium Enterprises (MSMEs) is critical for generating demand and promoting the revival of the post COVID-19 economy. In order to analyse the impact of COVID-19 on this sector and to discuss future strategies for MSMEs, the IGFP in collaboration with the Odisha Small Industries Corporation (OSIC) and with support of the MSME Department, Government of Odisha, organised a workshop at Hotel Presidency Bhubaneswar on 16 January 2021.

More than 50 participants from MSMEs, government institutions and industry associations actively participated. All participants received a copy of the guidebook "7 Golden Rules for Small Businesses". The guide was issued by the International Social Security Association (ISSA) specifically for the safety needs of SMEs (for more information on the guide, see page 2).
