- Slip, trip and falls
- Ladders
- Falling Objects
- Electricity
- Hazardous substances



Structure: 43 scenarios



### Covid-19



- First registered Infection January 2020.
- In the following weeks Corona Virus spreaded out in whole Germany. The first Lockdown started 22. März 2020.
- Two more infection waves followed from Oktober 20 until January 2021 und from April 2021.
- Today more than 50% of the population is already vaxinated.



The construction industry in Germany (like all over in this world) faced huge challenges in spring 2020:

No one was prepared for this pandemic (not enough knowledge how to handle it, not enough PPE available) etc.



For many industries the lockdowns were very hard.

But the German construction industry didn't stop all the time.

Hygiene – a little bit neglected topic before Corona – becomes very important.

Regarding hygiene on construction sites there were already strict regulations excisting before the pandemic. But the pandemic changed the behaviour in a very positive way.

Today 95 % of the construction sites are following the hygiene regulations perfectly.



# How to check if the 7 Golden Rules are well implemented?

## By using a rating system...

#### **HOW THE STOP LIGHTS WORK**

Rate my company or worksite using the elements below. Just check the stop light for each action item:

- No action is required at the present time
- Action required
- Urgent action required
- Not applicable

- Employees should always feel responsible for their own and their co-worker's safety.




